NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Assistant Counsel Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

- (1) On October 25, 2013, the Illinois EPA issued an Administrative Citation to Respondents Gwendolyn Sutton and Milton "Rusty" Sutton, based on an inspection conducted on September 11, 2013.
- (2) On October 28, 2013, Milton "Rusty" Sutton was served with the Administrative Citation. The proof of service was filed with the Board on October 30, 2013.
- (3) The Administrative Citation issued to Gwendolyn Sutton was sent back to the Illinois EPA from the United States Postal Service, as unclaimed. Additionally, an attempt was made, by the Springfield Regional Inspector, to hand deliver the Administrative Citation. However, this attempt was unsuccessful.

(4) Because Respondent, Gwendolyn Sutton was not timely served within 60 days as required by 415 ILCS 5/31.1(b), the Administrative Citation should be dismissed.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board dismiss the pending action against Gwendolyn Sutton.
