REQUEST FOR NINETY DAY EXTENSION OF APPEAL PERIOD

NOW COMES the Respondent, the Illinois Environmental Protection Agency ("Illinois EPA"), by one of its attorneys, John J. Kim, Assistant Counsel and Special Assistant Attorney General, and, pursuant to Section 40(a)(1) of the Illinois Environmental Protection Act (415 ILCS 5/40(a)(1)) and 35 Ill. Adm. Code 105.208, hereby requests that the Illinois Pollution Control Board ("Board") grant an extension of the thirty-five (35) day period for petitioning for a hearing to August 25, 2003, or any other date not more than a total of one hundred twenty-five (125) days from April 21, 2003, the date of the Illinois EPA's final decision. The 125th day actually falls on August 24, 2003, a Sunday. The next business day is August 25, 2003. In support thereof, the Illinois EPA respectfully states as follows:

- 1. On April 21, 2003, the Illinois EPA issued a final decision to the Petitioner. (Exhibit A)
- 2. On May 27, 2003, the Illinois EPA received a written request from Petitioner for an extension of time by which to file a petition for review, asking the Illinois EPA join in requesting that the Board extend the thirty-five day period for filing a petition to ninety days. The Petitioner did not represent when the final decision was received. (Exhibit B)

3. The additional time requested by the parties may eliminate the need for a hearing in this matter or, in the alternative, allow the parties to identify issues and limit the scope of any hearing that may be necessary to resolve this matter.

WHEREFORE, for the reasons stated above, the parties request that the Board, in the interest of administrative and judicial economy, grant this request for a ninety-day extension of the thirty-five day period for petitioning for a hearing.

The Illinois Environmental Protection Agency (Illinois EPA) has reviewed the second amendment to the Site Classification Work Plan Budget submitted for the above-referenced incident. The second amendment to the Site Classification Work Plan Budget, dated February 10, 2003, was received by the Illinois EPA on February 11, 2003. Citations in this letter are from the Environmental Protection Act (Act) and 35 Illinois Administrative Code (35 Ill. Adm. Code).

The Illinois EPA is modifying the second amendment to the Site Classification Work Plan Budget pursuant to 35 Ill. Adm. Code 732.305(c) and Section 57.7(a)(1) of the Act. Based on the modifications listed in Section 2 of Attachment A, the amounts listed in Section 1 of Attachment A are approved.

- 1. \$70.00 for an adjustment in the monitoring well installation costs (bentonite pellets (50 lbs. pail)). The Illinois EPA has determined that these costs are not reasonable as submitted (Section 57.7(c)(4)(C) of the Act and 35 Ill. Adm. Code 732.606(hh)). One of the overall goals of the financial review is to assure that costs associated with materials, activities and services are reasonable (35 Ill. Adm. Code 732.505(c)).
 - a. The Illinois EPA previously approved \$125.00 for bentonite pellets (5 pails).
 - b. An additional \$55.00 is approved for bentonite pellets (5 pails) as the result of an increase in the Illinois EPA's unit rate for bentonite pellets.
- 2. \$848.00 for an adjustment in the personnel costs (first field project manager: well development/purging/sampling, survey/slug test wells). The Illinois EPA has determined that these costs are not reasonable as submitted (Section 57.7(c)(4)(C) of the Act and 35 Ill. Adm. Code 732.606(hh)). One of the overall goals of the financial review is to assure that costs associated with materials, activities and services are reasonable (35 Ill. Adm. Code 732.505(c)).
 - a. The Illinois EPA previously approved \$848.00 for the first field project manager (16 hours).
 - b. An additional \$192.00 is approved for the first field project manager (16 hours) as the result of an increase in the Illinois EPA's unit rate for field project managers.
- 3. \$285.00 for an adjustment in the personnel costs (project manager: billing package). The Illinois EPA has determined that these costs are not reasonable as submitted (Section 57.7(c)(4)(C) of the Act and 35 Ill. Adm. Code 732.606(hh)). One of the overall goals of the financial review is to assure that costs associated with materials, activities and services are reasonable (35 Ill. Adm. Code 732.505(c)).
 - a. It is the account technician/reimbursement specialist's responsibility to prepare and proofread the billing package.
 - b. The Illinois EPA previously reduced the unit rate for the project manager (billing package) to the unit rate for an account technician/reimbursement specialist.
- 4. \$65.00 for an adjustment in the equipment costs (water level indicator). The Illinois EPA has determined that these costs are not reasonable as submitted (Section 57.7(c)(4)(C) of the Act and 35 Ill. Adm. Code 732.606(hh)). One of the overall goals of the financial review is to assure that costs associated with materials, activities and services are reasonable (35 Ill. Adm. Code 732.505(c)).
 - a. The Illinois EPA previously approved \$164.00 for the water level indicator (4 days).
 - b. No additional monies can be approved as the result of a reduction in the Illinois EPA's unit rate for water level indicator.

Appeal Rights

An underground storage tank owner or operator may appeal this final decision to the Illinois Pollution Control Board pursuant to Sections 40 and 57.7(c)(4)(D) of the Act by filing a petition for a hearing within 35 days after the date of issuance of the final decision; however, the 35-day period may be extended for a period of time not to exceed 90 days by written notice from the owner or operator and the Illinois EPA within the initial 35-day appeal period. If the owner or operator wishes to receive a 90-day extension, a written request that includes a statement of the date the final decision was received, along with a copy of this decision, must be sent to the Illinois EPA as soon as possible.
