

HEARING OFFICER ORDER

On November 12, 2013, the remaining respondent, Reliable Materials Lyons, LLC (Reliable), and the complainant participated in a telephonic status conference with the hearing officer. The complainant stated that the parties are close to resolving the approved supplemental environmental project to be included in the stipulation and proposal for settlement (stipulation) and are optimistic that a stipulation will be filed by the next status conference. By agreement, Reliable's answer or other pleading is now due to be filed on or before February 7, 2014.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 16, 2014, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.


