<u>AC 18-17</u>	<u>County of Macon v. Euroclydon, Inc.</u> (Land) – The Board found that respondent had violated Sections 21(p)(1) and 21(p)(7) of the Act (415 ILCS 5/21(p)(1) and 21(p)(7) (2016)). Because there were two violations of Section 21(p), the Board ordered respondent to pay a civil penalty of \$3,000.	5-0

<u>PCB 17-15</u>	<u>Illinois Power Generating Company v. IEPA</u> (Water, NPDES - Permit Appeal) – The Board granted petitioner’s motion for voluntary dismissal of this permit appeal.	3-0 B.K. Carter and C.M. Santos abstained
<u>PCB 18-83</u>	<u>John D. Warsaw v. IEPA</u> (UST Appeal) – The Board accepted for hearing this underground storage tank appeal involving a site in Tazewell County.	5-0

<u>PCB 19-2</u>	<u>Reliable Stores, Inc. v. Office of State Fire Marshal</u> (UST Appeal) – The Board accepted the petition for review as timely but directed petitioner to file an amended petition remedying the deficiencies identified in the order on or before August 27, 2018, or the appeal will be subject to dismissal.	5-0
<u>PCB 19-3</u>	<u>Village of Hazel Crest v. IEPA</u> (Air - Permit Appeal) – The Board accepted for hearing this air permit appeal involving a site in Cook County.	5-0
<u>PCB 19-4</u>	<u>People of the State of Illinois v. Peoria Barge Terminal, Inc., and Morton Salt, Inc.</u> (Water – Enforcement) – The Board accepted for hearing this water enforcement action involving a site in Peoria County.	5-0
<u>PCB 19-5</u>	<u>Brummer Porkers v. IEPA</u> (Water – Tax Certification) – The Board found and certified that specified facilities of Brummer Porkers located in Effingham County are pollution control facilities for the purpose of preferential tax treatment under the Property Tax Code (35 ILCS 200/11-10 (2016)).	5-0
