ORDER OF THE BOARD (by C.K. Zalewski):

On August 24, 2018, the Board consolidated 34 new petitions for a chloride time-limited water quality standard (TLWQS) with <u>Village of Homewood et al v. IEPA</u>, PCB 16-14 (consol.) (<u>Homewood</u>). In that order the Board found that "the pollutant and watershed addressed by the new TLWQS petitions are the same as those addressed by the class established in <u>Homewood</u>." <u>Homewood</u>, PCB 16-14 (consol.), slip op. at 4 (Aug. 24, 2018). The Board also found that 32 of the 34 petitions were timely filed and are eligible for the stay of the chloride water quality standard. *Id.* at 5.

On September 11, 2018, Ingredion, Inc. motioned the Board to sever its petition (PCB 19-32) from the consolidated docket. The Board grants this request. And on September 14, 2018, the Village of Crestwood (PCB 19-40) petitioned the Board to extend the filing deadline for the chloride water quality standard stay. The Board also grants this request. In this order, the Board first discusses Ingredion's motion to sever, and then addresses the Village of Crestwood's petition for extension of deadline.

MOTION TO SEVER

Ingredion filed a motion to sever claims (Mot.) on September 11, 2018. Ingredion explains that its July 26, 2018 petition (PCB 19-32) seeks a temperature TLWQS from the Board's water regulations, 35 Ill. Adm. Code 302.408(b)-(f), & (h), which is distinct from the

pollutant in the <u>Homewood</u> class. Mot. at 2-3. Remaining consolidated with the <u>Homewood</u> TLWQS class would prejudice both Ingredion and the <u>Homewood</u> class members. *Id.* at 3. Ingredion requests the Board sever its claims from the consolidated chloride TLWQS in <u>Homewood</u>.

Because Ingredion is not a member of the <u>Homewood</u> class, the Board removes PCB 19-32 from this consolidated docket. And any chloride water quality standards that would apply to Ingredion are not stayed. Future filings in PCB 16-14 (consol.) must reflect the updated caption of this order.

PETITION FOR DEADLINE EXTENSION

The Village of Crestwood filed a petition (Pet.) requesting an extension of the filing deadline for the chloride water quality standard stay. The filing deadline to qualify for a stay of the chloride water quality standard was July 26, 2018. <u>Homewood</u>, PCB 16-14 (consol.), slip op. at 4 (Aug. 23, 2018). The Village of Crestwood filed its chloride TLWQS petition on August 1, 2018. The Village of Crestwood claims that its late submittal was due to an extended review of its petition and supporting materials to ensure the completeness and veracity of the filing. Pet. at 2-3. The Board finds good cause and grants an extension of the filing deadline for Village of Crestwood. *See* 35 Ill. Adm. Code 104.540, Board Note. The chloride water quality standard, therefore, is stayed as to the Village of Crestwood. *See* 415 ILCS 5/38.5(h)(1) (enacted by P.A. 99-937, eff. Feb. 24, 2017); *see also* 35 Ill. Adm. Code 104.525(a)(3).

IT IS SO ORDERED.
