RESOLUTION AND ORDER OF THE BOARD (by J. D. Dumelle):

This matter comes before the Board upon a February 6, 1985 publication of notice (50 Fed. Reg. 5190) by the United States Environmental Protection Agency (USEPA) of the promulgation of standards for sources of emissions of radionuclides to air under the National Emission Standards for Hazardous Air Pollutants (NESHAP):

Subpart H - National Emission Standard
for Radionuclide Emissions from Department
of Energy (DOE) Facilities - 40 CFR 61
(35 Ill. Adm. Code 231.180);

Subpart I - National Emission Standard
for Radionuclide Emissions from Facilities
Licensed by the Nuclear Regulatory Commission
(NRC) and Federal Facilities Not Covered by
Subpart H - 40 CFR 61 (35 Ill. Adm. Code 231.190); and

Subpart K - National Emission Standard
for Radionuclide Emissions From Elemental
Phosphorus Plants - 40 CFR 61
(35 Ill. Adm. Code 231.210).

Pursuant to Section 9.1 of the Environmental Protection Act, the Board is required to adopt rules "in substance identical" to the federally adopted NESHAP rules. The Board will do so through incorporation by reference of the federal rules as peremptory rules.

ORDER

The Board hereby adopts the following amendments to Title 35: Environmental Protection; Subtitle B: Air Pollution; Chapter I: Pollution Control Board; Part 231: Hazardous Air Pollutants:

Subpart H

Section 231.180 Radionuclide Emissions from Department of Energy (DOE) Facilities

The Board incorporates by reference 40 CFR 61, Subpart H as adopted at 50 Fed. Reg. 5190, February 6, 1985.

Subpart I

Section 231.190 Radionuclide Emissions from Facilities Licensed by the Nuclear Regulatory Commission (NRC) and Federal Facilities Not Covered by 35 Ill. Adm. Code 231.180

The Board incorporates by reference 40 CFR 61, Subpart I as adopted at 50 Fed. Reg. 5190, February 6, 1985.

Subpart K

Section 231.210 Radionuclide Emissions from Elemental Phosphorus Plants

The Board incorporates by reference 40 CFR 61, Subpart K as adopted at 50 Fed. Reg. 5190, February 6, 1985.
