HEARING OFFICER ORDER

On September 27, 2018, all parties participated in a telephonic status conference with the hearing officer. The respondent again stated that on August 16, 2018, a third plumber visited the site and the parties continue to await his inspection report. Complainant further stated that she may attempt to contact another plumber to assess the situation at the site. To date, the parties are receipt of two inspection reports from two different plumbers. Counsel for respondent will consult with their client whether that is sufficient. It was agreed to continue this matter to the date and time noted below.


The respondent stated that it has forwarded a settlement document to the complainant for her review.

To that end, complainant is to file her response to respondent's motion to dismiss for want of prosecution by November 1, 2018. The parties will revisit this due date at the next status conference.

Any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent's motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 25, 2018, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


