HEARING OFFICER ORDER


On March 20, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner has indicated that it is not prepared to file an additional waiver of the statutory decision deadline and has requested a hearing to be held on April 30, 2014.

Discussions also took place regarding the proposed discovery schedule that the petitioner filed with the Board on March 19, 2014. The respondent stated that it will file a response on or before March 21, 2014. Further, it was suggested that the parties discuss the proposed discovery schedule prior to the next status conference.

The respondent stated that it intends to timely file the record in this matter on March 24, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 24, 2014, at 11:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


