HEARING OFFICER ORDER

On November 1, 2018, all parties participated in a telephonic status conference with the hearing officer. Complainant stated that she objects to the terms of the most recent plumber that would visit her site and offer an estimate on repair. Apparently, she would have to sign a contract and forward a down payment. I asked the parties if they could work this issue out.

Counsel for the respondent stated that on November 13, 2018, the Board for the Highland Hills Sanitary District will meet and decide how to proceed with this matter, including reviewing a settlement proposal. Counsel further stated that by mid-December, the County will most likely decide to dissolve Highland Hills Sanitary District and appoint a trustee.

To that end, complainant is to file her response to respondent's motion to dismiss for want of prosecution by November 30, 2018.

Any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent's motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 20, 2018, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
