I have begun work on incorporating the October 12, 2018 USEPA designation of additional alternative equivalent methods for drinking water analyses. I will ultimately need to buy a copy of Standard Methods, 23rd edition for incorporation by reference.

USEPA lists many methods separately as available from SM Online. We prefer to not list the methods separately if they appear in a printed volume. We incorporate the bound volume by reference, allowing use of the same version if obtained through SM Online. I have reviewed the methods separately listed by USEPA and found most of them in the 21st and 22nd editions of Standard Methods. I have a lingering question that I hope you will answer. I do not wish to put a hold on my work pending getting a copy of the 23rd edition.
