## **HEARING OFFICER ORDER**

On November 20, 2018, all parties participated in a telephonic status conference with the hearing officer. Complainant stated that she is confused and that she has been unable to receive an updated proposal. Respondent's counsel stated that he forwarded by e-mail two settlement proposals that the Highland Hills Board approved. Complainant stated that she did not receive them, at least not the dollar amounts.

I directed the parties to discuss the proposals starting today, either orally or through email. The complainant to respond to respondent's regarding her decision on the proposals on or before November 26, 2018. The parties are directed to file a written status report on or before December 4, 2018.

To that end, complainant is to file her response to respondent's motion to dismiss for want of prosecution by December 14, 2018.

Any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent's motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 6, 2018, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
