
**HEARING OFFICER ORDER**

On December 6, 2018, all parties participated in a telephonic status conference with the hearing officer. Counsel for petitioners and respondent stated that there is an agreement in substance and that additional technical information from the petitioners will be forwarded to the respondent soon. The parties are hopeful that a permit will be issued 3 to 4 months.

Counsel for petitioner stated that he will file an additional waiver of the statutory decision deadline to and including June 6, 2019.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on February 21, 2019, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




