HEARING OFFICER ORDER

On December 6, 2018, all parties participated in a telephonic status conference with the hearing officer. Complainant stated that she was confused as to what she could include in her status report that she was directed to file by December 4, 2018. I told her it was prerogative to include whatever she wanted. She was given to December 7, 2018 to file her written status report.

Counsel for respondent explained that its client has filed a petition for dissolution and is scheduled for December 18, 2018 to be heard in circuit court. Depending on the ruling, the court could appoint a trustee and Highland Hills Sanitary District could be dissolved within the next 5 months.

In respondent's status report filed on December 3, 2018, it appears there are a couple of settlement options offered to the complainant. She has yet to respond to the settlement offers. Complainant was again advised to retain an attorney since it appears she remains confused about the process.

To that end, complainant is to file her response to respondent's motion to dismiss for want of prosecution by January 3, 2019.

Any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent's motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 13, 2018, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
