HEARING OFFICER ORDER


A third telephonic status conference was scheduled for February 28, 2019. Neither party appeared, nor have they ever appeared for a telephonic status conference.

On July 3, 2018, complainant filed a formal complaint. On August 31, 2018, respondent filed an answer and an appearance was filed by an attorney representing respondent. On October 4, 2018, the Board directed complainant to file an amended complaint. On October 26, 2018, complainant filed an amended complaint. On December 20, 2018, the Board accepted the amended complaint for hearing. Respondent has not filed an answer or otherwise responded to the amended complaint.

I have so far scheduled three telephonic conferences directing the parties or their representatives to appear. No one has appeared. As noted below, I have scheduled a fourth telephonic status conference. If no one appears, I am inclined to refer this matter to the Board for a ruling, including a possible dismissal of the above-captioned citizens enforcement matter.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 21, 2019, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance.


