I put together the key sections of the Environmental Protection Act related to air pollution, open burning, and landscape waste. These sections are highlighted in yellow:

- Section 3.115 - Definition of "air pollution"
- Section 3.270 - Definition of "landscape waste"
- Section 9(a) - Prohibition of causing air pollution
- Section 9(c) - Prohibition of certain types of open burning
- Section 9(f) - Allowances for open burning of landscape waste in particular situations.

I highly recommend that you seek the assistance of legal counsel in preparing the revision of your Illinois Pollution Control Board complaint.
