**RESPONDENT ILLINOIS ENVIRONMENTAL PROTECTION AGENCY'S
MOTION FOR EXTENSION OF TIME IN WHICH TO FILE
THE ADMINISTRATIVE RECORD**

NOW COMES Respondent, the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (“Illinois EPA”), and moves the Pollution Control Board (“Board”), pursuant to Section 105.116(a) of the Board’s Procedural Rules, 35 Ill. Adm. Code 105.116(a), for an extension of time by which to file the administrative record in this third-party permit appeal. Respondent states the following in support of this motion:

1. On April 11, 2019, the Board issued an order in this matter setting a May 2, 2019 deadline by which the Illinois EPA was to file the administrative record in this third-party permit appeal.
2. The parties have been in settlement discussions to resolve this matter. Based on those ongoing discussions, the Illinois EPA requests an additional 45 days to file the administrative record. The Illinois EPA has advised counsel for Petitioner Citizens against Ruining the Environment and Respondent Jackson Generating, LLC of its request and has been informed that neither party objects to an extension of the time for filing the administrative record.

WHEREFORE, Respondent, the Illinois Environmental Protection Agency, respectfully requests that it be given until June 17, 2019, by which to file the administrative record in this matter.
