
HEARING OFFICER ORDER

On February 18, 2016, all parties participated in a telephonic status conference with the hearing officer. The parties stated that excellent progress has been achieved in the resolution of the above-captioned appeal. The parties were directed to file a written response to the following questions: How does petitioner's intention to rely on non-coal fired generating capacity at the Fisk facility impact permit negotiations; how does the transition from coal to non-coal as a fuel source at the Joliet facility change the permitting negotiations; are certain issues resolved due to that transition; are there new issues to negotiate due to that transition; and what is the estimated timeframe for resolution of this appeal. The parties were directed to file a written response, either jointly or otherwise, on or before March 14, 2016

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 4, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 7, 2016, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


