Good morning, Kathe. I wanted to touch base with you to give some additional information on what I'm looking for. We need a copyright permissions letter allowing us to make three copies of an ASTM standard to be given to the Pollution Control Board for the purposes of rulemaking. One copy will also be made for the attorney in charge of the rulemaking to be filed with their other pertinent information pertaining to it. Of course, we are still paying for the subscription/original download, and we intend to keep that subscription active.

We have a similar arrangement with the American Water Works Association. They provide a letter that states

December 1, 2009.

Please let me know if I can provide you with any additional information to assist us with this. I really appreciate your help. We're all extremely pleased with ASTM's willingness to grant us free copyright permissions for the purposes of rulemaking.

Good morning. I'm with the Illinois Environmental Protection Agency. I've been asked by one of our staff to contact you regarding two NSF standards (NSF 60-2014 and NSF 61-2014). We are interested in incorporating these two standards into an environmental rulemaking with our Pollution Control Board. The Board requires us to submit four copies of all standards incorporated into a rulemaking. I checked with TechStreet this morning and found that the standards are \$325 each. Unfortunately, that is outside of our budget capabilities.

I'm contacting you to see if there is an arrangement that can be made to provide four copies of each standard to our Pollution Control Board for the purposes of rulemaking for a reduced cost or for free. I've negotiated similar arrangements with the American Water Works Association and ASTM to provide us copyright permissions for Board rulemakings for free. We've agreed that they would not be distributed digitally and that they were for rulemaking purposes only. Is it possible to arrange something similar so that these standards can be included as planned?
