HEARING OFFICER ORDER

On December 12, 2013, a telephonic status conference was held. The respondent did not appear. The petitioner informed the hearing officer that language for one of the related permits has been resolved and was utilized in a related permit appeal and will be the model for the remaining related permit appeals. *See* PCB 06-64. The petitioner represented that it will file an additional waiver of the statutory decision deadline to an including July 10, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 6, 2014, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. IT IS SO ORDERED.


