HEARING OFFICER ORDER

On November 24, 2015, all parties participated in a telephonic status conference with the hearing officer. The respondent's attorney stated that petitioner recently signed a permit modification letter that has been reviewed and approved by the Illinois Environmental Protection Agency. The modification will be incorporated into a draft permit.


Further, the petitioner stated that it may need to request another permit modification due to some unforeseen issues.

To that end, it was agreed the respondent's response to petitioner's motion for summary judgment is now due to be filed, if needed, on or before December 30, 2015. The respondent's response time may be revisited at the next status conference.

Petitioner stated that it will file an additional waiver of the statutory decision due date to and including April 7, 2016.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 17, 2015, at 9:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. A hearing date may also be discussed.


