
**HEARING OFFICER ORDER**

On September 18, 2019, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it appears respondents William and Debra Mucci (Muccis) have reached a settlement. The complainant will forward a draft stipulation and proposal for settlement to the Muccis' for their review. It was agreed that the Muccis' answer is now due on or before December 2, 2019.

The complainant stated that respondents John and Polly Kirby (Kirby) will soon commence settlement discussions. Kirbys' answer due date has not been extended.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 14, 2019, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




