RESPONSE BY PETITIONER VILLAGE OF ORLAND PARK TO THE QUESTIONS AND DRAFT ORDER OF ILLINOIS POLLUTION CONTROL BOARD

In a December 20, 2018 Board order, the Illinois Pollution Control Board stated that it "may submit questions to the Joint Petitioners and the Agency through a Board or hearing officer order prior to the public hearing." Village of Homewood et al., v. IEPA, PCB 16-14 (consol.), slip op. at 5 (December 20, 2018). To that end and to assist the Board in its consideration of the petitions, the parties were directed, pursuant to the Hearing Officer Oder dated July 24, 2019, to file their respective responses to the questions found in the attachment to that Hearing Officer Order, by September 23, 2019. The Petitioners were also asked to comment on the draft language or propose revised language for a Board Order.

The Village of Orland Park hereby joins in, adopts, and incorporates into its Response to the questions and the draft order of the Illinois Pollution Control Board, the response, suggestions, and markups contained in the Response to the questions and draft order of the Illinois Pollution Control Board filed by the Metropolitan Water Reclamation District of Greater Chicago (PCB 16-29) with the following comments with respect to draft Board Order Table 2: Individual Dischargers and Receiving Waters:

1. The key at the bottom on Page 28 lists CSC as CSG– Cal Sag Channel, this should be corrected.

2. Receiving Waters applicable to the Village of Orland Park should include the following: Mill Creek, Tinley Creek, Midlothian Creek and Long Run Creek. The Village understands that these four creeks may not be listed separately because they flow into other waterways, but for clarification the Village suggests that it would be beneficial to have them listed separately.
