
**HEARING OFFICER ORDER**

On July 1, 2013, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it intends to have a meeting with the respondent within three weeks discussing a revised adjusted standard petition that would render unnecessary the above-captioned appeal. Petitioner stated that its' intention is to file an adjusted standard petition in the next four weeks.

To that end, petitioner will file a waiver of the statutory decision deadline to and including November 21, 2013. It was agreed that respondent's record is now due to be filed on or before September 13, 2013, if needed.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 21, 2013, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


