
**HEARING OFFICER ORDER**

On April 28, 2016, all parties, including the interested party, Mr. Albert Ettinger, participated in a telephonic status conference with the hearing officer. The respondent Illinois Environmental Protection Agency (Agency) stated that it has recently discussed the above-captioned variance with the United States Environmental Protection Agency (USEPA) and will hold additional discussions next week with petitioner Midwest Generation and the USEPA. By agreement, the Agency's recommendation is now due on or before June 1, 2016. The due date for the recommendation will be revisited at the next status conference.

Petitioner stated that it will file an additional waiver of the statutory decision deadline to and including October 6, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 19, 2016, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




