The respondent stated that legislative changes in 2017 may affect these related variances.

Petitioner Metropolitan Reclamation District of Greater Chicago agreed to file a joint waiver of the statutory decision deadline to and including June 1, 2017.

It was agreed that respondent's recommendation is now due to be filed on or before March 23, 2017.
