ADJUDICATORY CASES

<u>PCB 09-96</u>	Holland Energy, LLC v. IEPA (Air – Permit Appeal, CAAPP) – The Board granted petitioner's motion for voluntary dismissal of this permit appeal.	4-0
<u>PCB 20-1</u>	People of the State of Illinois v. Pitchford Elevator Company (Land, Air – Enforcement) – Upon receiving a proposed stipulation and settlement agreement and an agreed motion for relief from the hearing requirement in this land and air enforcement action involving a facility located in Washington County, the Board ordered publication of the required newspaper notice.	4-0
<u>PCB 20-3</u>	People of the State of Illinois v. Signcraft Screenprint, Inc. (Air – Enforcement) – In this air enforcement action concerning a Jo Daviess County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2018)), accepted a stipulation and settlement agreement, and ordered respondent to both pay a total civil penalty of \$37,500 and cease and desist from future violations.	4-0
<u>PCB 20-9</u>	People of the State of Illinois v. Chicago Tire, Inc. and Chicago Industrial Retreaders, Inc. (Air – Enforcement) – In this air enforcement action concerning a Cook County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2018)), accepted a stipulation and settlement agreement, and ordered respondents to both pay a total civil penalty of \$13,375 and cease and desist from future violations.	4-0

<u>PCB 20-41</u>	Dare Farms, LLP v. IEPA (Water – Tax Certification) – The Board accepted the petition as timely filed but found that the petition was deficient. The Board directed Dare Farms to file an amended petition with the Board by March 23, 2020.	4-0
PCB 20-47	<u>IMTT Illinois, LLC v. IEPA</u> (Water, NPDES-Permit Appeal) – The Board construed IMTT Illinois' agreed request to extend the appeal period as a timely petition for review and directed IMTT Illinois to file an amended petition for review by April 20, 2020.	4-0
<u>PCB 20-53</u>	<u>Premcor Refining Group, Inc. v. IEPA</u> (UST Appeal) – The Board granted this request for a 90-day extension to file an underground storage tank (UST) appeal on behalf of this Peoria County facility.	4-0
