
HEARING OFFICER ORDER

On April 24, 2020, Mr. LaRose, the attorney for respondent Community Landfill Company, Inc. (CLC) filed an “Unopposed Motion for Leave to Withdraw as Attorney of Record for Respondent Community Landfill Company, Inc. (Mot.) Mr. LaRose states that CLC is a dissolved and defunct company with no assets. Mot. At 2. Brothers Edward and Robert Pruim (Pruim) are unemployed with serious health issues. *Id.* The Pruiims’ cannot pay Mr. LaRose for outstanding bills, and as former officers of CLC, have given their consent to Mr. LaRose to withdrawl as counsel. *Id.* At 3. Further, the motion states that both respondent City of Morris and the complainant, People of the State of Illinois, do not object. *Id.* No response has been filed.

Mr. LaRose’s motion is granted and the Clerk is directed to remove his name and his firms name, LaRose and Bosco, from the service list.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 10, 2020, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


