
HEARING OFFICER ORDER

On June 10, 2020, a telephonic status conference was held. Respondent Community Landfill Company (CLC) did not appear. Note that I granted CLC's attorney's motion to withdraw as counsel of record on May 19, 2020.

The complainant and respondent, City of Morris (City) had a settlement discussion on June 4, 2020. At present, complainant is deciding whether to move to dismiss its proceeding in circuit court and file an amended complaint with the Board or a new complaint. The complainant stated that filing(s) with the Board will hopefully be accompanied with a stipulation and proposal for settlement with the City.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 17, 2020, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


