HEARING OFFICER ORDER

On July 26, 2018, the Metropolitan Water Reclamation District of Greater Chicago (MWRD) filed an amended petition for a dissolved oxygen (DO) time-limited water quality standard (TLWQS). 35 Ill. Adm. Code 104 Subpart E. MWRD is seeking TLWQS for discharges from Combined Sewer Overflow (CSO) outfalls into the Chicago Area Waterways System. MWRD requests TLWQS for CSO outfalls covered under the National Pollutant Discharge Elimination System permits issued to its O'Brien, Calumet and Stickney wastewater treatment plants. On March 28, 2019, the Board found that MWRD's amended petition is in substantial compliance with the Environmental Protection Act and Board regulations. The Board directed the hearing officer to schedule a public hearing. MWRD v. IEPA, PCB 16-28 (March 28, 2019).

The hearing will be by videoconference between the Board's offices. Today's order sets the dates for the hearing and the prefiling deadlines for written testimony and questions.

The Board's procedural rules provide that "[a]ny Board hearing may be held by videoconference." The rule provides factors that a hearing officer will consider in determining whether to hold a hearing by videoconference. *See* 35 Ill. Adm. Code 101.600(b). Videoconference hearings reduce travel costs for Board members and staff, witnesses and participants. Based on these considerations, the hearing will be conducted by videoconference between its offices.

Matters to be discussed at the hearing are issues related to dissolved oxygen TLWQS applicable to discharges from MWRD's CSO outfalls into the CAWS. Below is a link to the Board's website where the initial petition and the amended petition can be obtained along with

Hearing and Pre-Filed Testimony and Questions

The Board will conduct this hearing to allow the MWRD, the IEPA and any other interested participants to testify and present comments on the merits. Participants may make relevant oral statements on the record and must be made under oath and subject to cross-examination. All persons wishing to testify at hearing will be sworn in and subject to questioning. *See* Ill. Adm. Code 101.628 (a). Any participant may submit written statements relevant to the subject matter at any time before hearing or at hearing and will be subject to cross-examination. *See* Ill. Adm. Code 101.628 (b). Oral public comment may be made on the record at hearing and is not subject to cross-examination. *See* Ill. Adm. Code 101.628 (c).

Unless the Board, hearing officer, Clerk or procedural rules provide otherwise, all documents in this proceeding must be filed electronically through the Clerk's Office On-Line (COOL). 35 Ill. Adm. Code 101.302 (h), 101.1000 (c), Subpart J. Documents may generally be served be e-mail if the recipient has consented to e-mail service and has not revoked the consent. 35 Ill. Adm. Code 101.1060.

The deadline to pre-file answers to the Board's questions or other additional testimony is July 15, 2020, by 4:30 p.m. (the time the Clerk's office stops accepting filings date stamped that day). Pre-filed questions based on the pre-filed testimony must be filed with the Board, by July 25, 2020, at 4:30 p.m. The Board encourages MWRD to pre-file answers to any additional questions filed by July 25, 2020, before August 4, 2020.

For this videoconference hearing, any document to be offered as a hearing exhibit must be received by the Clerk's Office at least 24 hours before the scheduled start of the hearing. 35 Ill. Adm. Code 102.424 (h). If not filed at least 24 hours before scheduled start of the videoconference hearing, the document will not be allowed at the hearing but may be filed as a public comment after the hearing. *Id*.

The hearing will proceed as follows: the petition, responses to the questions from the Board, IEPA responses and replies to the Board and IEPA questions and responses will be admitted without further testimony. However, anyone may object at hearing regarding these admitted documents. An opening statement will be available to the parties if they choose. The petitioner will commence the hearing with their witnesses. Questions may be directed to the witnesses by, including but not limited to, the Board and the IEPA. After petitioner rests the IEPA will present its witness. Questions may be directed to him by, including but not limited to, the Board and the petitioner. After the IEPA rests, members of the public may ask questions, give testimony or comment. The hearing officer may make adjustments in the hearing procedure as needed.

Written Public Comment

Written public comment may be filed with the Board at any time until the conclusion of the comment period. That date will be announced by hearing officer order after the close of hearings. If you have any questions regarding written public comment you may contact the hearing officer or the Clerk of the Board.
