CHAIR'S UPDATE

Since March of this year, the Board restricted its in-person operations to help in combating the COVID-19 pandemic, as directed by Governor Pritzker in his disaster proclamations and related executive orders. But the core business of the Board—its rulemakings and adjudications—continued with little disruption or delay. We owe this to the teamwork and diligence of the Board's exceptional staff. I am deeply grateful to each and every one of them.

Faced with these unpredictable times, Board staff responded predictably. They investigated and saw to the successful implementation of new ways for safely participating in Board meetings and hearings. They maintained the smooth functioning of the Board's electronic filing, docketing, and notice systems, which are relied on by both the public and the Board. They ensured the Board's continued compliance with the Open Meetings Act, the Freedom of Information Act, and the Administrative Procedure Act, as well the Board's founding statute, the Environmental Protection Act. In short, they took all the steps required for the Board to meet the needs of its constituents—the people of Illinois.

Board meetings were held each month by teleconference, with members of the public able to listen in and make remarks using their telephones. At those meetings, the Board adopted opinions and orders in substantial rulemakings, including first notice in <u>Standards for the Disposal of Coal Combustion Residuals in Surface Impoundments: Proposed New 35 Ill. Adm. Code 845 (CCR)</u>, R20-19 (Apr. 16, 2020), second notice in <u>Proposed New 35 Ill. Adm. Code 204</u>, Prevention of Significant Deterioration, Amendments to 35 Ill. Adm. Code Parts 101,105, 203, 211, and 215, R19-1 (June 18, 2020), and final adoption in <u>Amendments to Manifesting Requirements: Special Waste Hauling 35 Ill. Adm. Code 809</u>, R19-18 (July 16, 2020). These and other rulemaking decisions are summarized in the "Rulemaking Update" of this *Environmental Register*.

The Board also held hearings that offered multiple means to participate, including in-person attendance with social distancing and remote attendance by either telephone or web-based video. Two rulemaking hearings were held in June: (1) Cross Connection Control Device Inspectors of Public Water Supplies at 35 Ill. Adm. Code 604.1520 (CCCDI), R20-21; and (2) Proposed New 35 Ill. Adm. Code 249 Ethylene Oxide Ambient Air Monitoring, R20-18. Three more rulemaking hearings were held this month: (1) CCCDI, R20-21; (2) National Ambient Air Quality Standards, USEPA Amendments (July 1, 2018 through December 31, 2018), R19-14, National Ambient Air Quality Standards, USEPA Amendments (January 1, 2019 through June 30, 2019), R20-3, National Ambient Air Quality Standards, USEPA Amendments (July 1, 2019 through December 31, 2019), R20-11 (consol.); and (3) Definition of VOM Update, USEPA Regulations (July 1, 2018 through December 31, 2018), R19-15. And hearings set for August and September are noted in the "Calendar" of this Environmental Register, including one in a time-limited water quality standard proceeding (Metropolitan Water Reclamation District of Greater Chicago v. IEPA, PCB 16-28) and one in a rulemaking (CCR, R20-19).

The Board did not limit itself, however, to processing its caseload. The Board celebrated its golden anniversary, turning 50 on July 1, 2020. Governor Pritzker marked the date by



proclaiming it "Pollution Control Board Day" in the State of Illinois. In his proclamation, the Governor commended the Board "for the important role it has played since 1970 in protecting the environment of Illinois and the health and well-being of its people." Also on the first of this month, the Board released its comprehensive 50th anniversary report entitled *At the Half-Century Mark: Illinois' Pollution Control Board and Environmental Protection Act*, which includes articles on the legislative battle to pass the Act, what made the Act revolutionary, and the Board's early years. The Governor's proclamation and the Board's 50th anniversary report, along with other commemorative materials, may be viewed on the Board's website (https://pcb.illinois.gov).

Lastly, we mourn the passing of the Board's long-time Clerk, Dorothy Gunn. For nearly half of the Board's 50-year existence, Dorothy was, to many, the face of the Board. Respected and warmly regarded inside and outside of this agency, Dorothy retired in 2007 after 32 years with the Board, the last 23 as Clerk. Our memorial tribute to Dorothy follows.

IN MEMORY OF DOROTHY GUNN

Dorothy Mae Gunn passed away peacefully on July 7, 2020, at the age of 78. As many reading this memorial know, Dorothy was the Clerk of the Illinois Pollution Control Board for well over two decades.

Less well known in the Board community are the early years of Dorothy's life. She was born on August 1, 1941, in West Helena, Arkansas, the youngest of six children. After her family relocated to Chicago, she graduated with honors from DuSable High School. She worked for Spiegel Clothing Company right out of high school and later received an associate degree from Harold Washington College, majoring in accounting.

Her service to the State of Illinois began in 1968 at the Youth Opportunity Center. In 1970, she joined the Illinois Bureau of Employment Security. Her career with the Board started in 1975 as a staff secretary. Before becoming Board's Clerk in 1984, she served as the private secretary to Board Member Irvin G. Goodman and then as a staff accounting assistant.

In her position as Clerk, from which she retired in 2007, Dorothy did everything expected of her and then some. Of course, she accepted and docketed filings, prepared meeting agendas and minutes, arranged for newspaper notices of hearings, and certified records to the Appellate Court, all while fulfilling other official duties as Clerk. She performed each of these tasks efficiently and tirelessly. She was also at the helm of the Clerk's Office as it ushered in electronic filing. Over Dorothy's unmatched tenure as Clerk, she established a well-earned reputation for professionalism, flexibility, and excellence.

But no matter how busy Dorothy was with her myriad responsibilities as Clerk, she would take the time to field procedural questions from members of the public and attorneys participating in Board proceedings, as well as from new Board staff. She was highly regarded as a friendly and helpful public servant and colleague.

Dorothy was with the Board for a remarkable 32 of its 50 years. She was beloved by Board Members and staff alike, and by those who appeared before the Board. She is sorely missed and will be forever remembered.

Long before she joined the Board, Dorothy developed a passion for gospel music. In fact, she was singing

with the Harold Bailey Singers in 1964 when she met and married Reverend Kenneth Hartzell Gunn. She directed the choir at Haven of Rest Missionary Baptist Church and assisted her husband with the renowned Second Generation Community Choir. Dorothy never boasted about





her vocal accomplishments, but she became one of Chicago's most outstanding gospel singers, ultimately featuring as a soloist on the Chicago Gospel Fest's main stage. It is a gross understatement to say that the "Happy Birthday" song at the Board has suffered without her melodious voice.

Kenneth and Dorothy celebrated their 56th wedding anniversary on February 15, 2020. She is survived by her husband and their two children, son D'Artagnon and daughter Tracey, two grandchildren, Kyla and Bianca, and four great grandchildren, Jaleel, Jalen, Kira, and Avani.



RULEMAKING UPDATE

Board Proposes First-Notice Rules for Ambient Air Monitoring of Ethylene Oxide

On January 16, 2020, the Board proposed new air monitoring rules for determining ambient levels of ethylene oxide (EtO) across Illinois (35 Ill. Adm. Code 249). Section 9.16(n) of the Environmental Protection Act (415 ILCS 5/9.16(n), added by P.A. 101-22, eff. June 21, 2019) requires the Illinois Environmental Protection Agency (IEPA) to both "conduct air testing to determine the ambient levels of [EtO] throughout the State" and, within a specified timeframe, "submit rules for ambient air testing of [EtO] to the Board." IEPA filed this rulemaking proposal on December 17, 2019. Without commenting on the substantive merits of IEPA's proposal, the Board proposed the rules for first-notice publication in the *Illinois Register*. See 44 Ill. Reg. 2216 (Jan. 31, 2020).

IEPA explains that there is no federal ambient air quality standard for EtO and that this rulemaking's purpose "is not to establish a standard for EtO in Illinois," but rather to establish "a system to ascertain baseline levels" of EtO across the State. Under the rules, IEPA expects to collect EtO monitoring data that will supplement the monitoring being conducted by the United States Environmental Protection Agency. IEPA proposes that the rules will no longer apply 24 months after they become effective.

The Board is accepting public comments on the first-notice proposal. The Board held a public hearing on June 25, 2020, and has another scheduled for September 10, 2020. The rulemaking is captioned Proposed New 35 Ill. Adm. Code 249 Ethylene Oxide Ambient Air Monitoring, docket R20-18. Board Proposes First-Notice Amendments to Adopt State PSD Permitting Program

On March 5, 2020, the Board proposed new and amended rules for first-notice publication in the *Illinois Register*. Specifically, the Board proposed a new Part 204 of its air pollution regulations to create a Prevention of Significant Deterioration (PSD) permitting program that would apply in Illinois instead of the federal PSD program. To accommodate PSD permit appeals, the proposal also would amend existing Parts 101 and 105 of the Board's procedural rules. In addition, to conform to the new Part 204, the proposal would amend existing Parts 203, 211, and 215 of the Board's air pollution regulations. *See* 44 Ill. Reg. 4316 (Mar. 20, 2020).

With its rulemaking proposal to the Board, the Illinois Environmental Protection Agency (IEPA) intended to satisfy the requirements of Section 9.1 of the Environmental Protection Act (Act) (415 ILCS 5/9.1(c) (2018); see Public Act 99-463, eff. Jan. 1, 2016), which calls for the establishment of a State PSD program meeting the requirements of the federal Clean Air Act. As proposed, instead of IEPA making PSD permit determinations under federal PSD regulations (by delegation agreement with the United States Environmental Protection Agency (USEPA)), IEPA would make PSD permit determinations under Board PSD regulations. And IEPA's PSD permit

determinations would be appealable to the Board rather than to USEPA's Environmental Appeals Board.

The Board held two public hearings in this rulemaking. The Board also accepted public comments on all aspects of its first-notice opinion and order, including the Board's decision on the role of environmental justice in the proposed PSD permit program. As discussed later in this "Rulemaking Update," the Board issued its second-notice opinion and order on June 18, 2020.

This rulemaking is captioned <u>Proposed New 35 Ill. Adm. Code 204, Prevention of Significant Deterioration, and Amendments to 35 Ill. Adm. Code 101, 105, 203, 211, and 215, docket R19-1. Board Proposes CCR Surface Impoundment Rules for First Notice

On April 16, 2020, the Board issued a first-notice opinion and order proposing new rules concerning the disposal of coal combustion residual (CCR) in surface impoundments at power generating facilities (35 Ill. Adm. Code 845). The CCR rules had been proposed to the Board on March 30, 2020, by the Illinois Environmental Protection Agency (IEPA). Receiving IEPA's proposal started the Board's one-year statutory deadline to adopt final rules. Accordingly, the Board proceeded to first notice without commenting on the substantive merits of IEPA's proposal.

The first-notice rules were published in the *Illinois Register* on May 1, 2020 (44 Ill. Reg. 6696), beginning a period during which any person may file with the Board a public comment on the proposed rules. Currently, two public hearings are scheduled in this rulemaking: the first hearing is set for August 11, 12, and 13, 2020; and the second hearing is set for September 29 and 30 and October 1, 2020.

The rulemaking is captioned <u>Standards for the Disposal of Coal Combustion Residuals in Surface Impoundments: Proposed New 35 Ill. Adm. Code 845</u>, docket R20-19. Board Adopts Emergency Rule Extending Period to Renew Approvals for Cross Connection Control Device Inspectors of Public Water Supplies

On April 16, 2020, the Board issued an opinion and order adopting an emergency rule that extended the period for cross connection control device inspectors (CCCDIs) to renew their annual CCCDI approvals. The Board received the emergency rulemaking proposal from the Illinois Environmental Protection Agency (IEPA) on April 10, 2020.

CCCDIs play a significant role in protecting public health and welfare by helping to ensure that public water supplies are protected from connections to and contamination by unsafe sources of water. Generally, a CCCDI must renew his or her CCCDI approval each year between May 1



and June 30. See 35 Ill. Adm. Code 604.1510(b)(2). IEPA's emergency rulemaking proposal sought to extend this renewal period for 2020 because of delays caused by the COVID-19 pandemic. The Illinois Department of Public Health, due to COVID-19, had adopted emergency rules extending the deadline for plumbers' license renewals, and CCCDIs must be licensed plumbers. Based on Governor JB Pritzker's proclaimed state of emergency in response to the COVID-19 pandemic, as well as related factors, including a potential shortage in approved CCCDIs, the Board found that an emergency existed. The Board therefore adopted an emergency rule at 35 Ill. Adm. Code 604.1520 ("COVID-19 Emergency Provisions"), which changed the 2020 approval renewal period for CCCDIs to between August 31 and October 30.

The emergency rule took effect on April 17, 2020 (44 Ill. Reg. 7777 (May 1, 2020)) and remains in effect up to 150 days. The Board invited public comment on the fact that the emergency rule, having a maximum duration of 150 days, would expire before the extended deadline of October 30, 2020. To address this gap, the Board opened a separate docket (R20-21) for a general rulemaking, as discussed later in this "Rulemaking Update."

The emergency rulemaking is captioned <u>Emergency Rulemaking for Cross Connection Control Device Inspectors of Public Water Supplies at 35 Ill. Adm. Code 604.1520</u>, docket R20-20. Board Adopts "Identical-in-Substance" Amendments to Drinking Water Rules

On April 16, 2020, the Board adopted amendments to Illinois' primary drinking water regulations in 35 Ill. Adm. Code 611. The amendments are "identical in substance" to rule amendments adopted by the United States Environmental Protection Agency (USEPA) during the second half of 2018. Specifically, USEPA adopted approximately 100 new methods for demonstrating compliance with the National Primary Drinking Water Regulations. Most were updated methods appearing in the recent 23rd edition of *Standard Methods for Examination of Water and Wastewater*.

In addition, the Board reorganized Part 611's incorporations by reference to simplify them, make them easier to use, and facilitate future amendments. The Board also updated sources for USEPA methods, corrected some methods' listings, and deleted two methods: one was a national standard that is no longer required; the other was not available from its former federal source or any source the Board could find.

Board Proposes Second-Notice Amendments to Non-Hazardous Special Waste Manifest Rules

On May 21, 2020, the Board issued a second-notice opinion and order proposing to amend its manifesting regulations on transporting non-hazardous special waste. In doing so, the Board addressed each of the public comments received during the first-notice period and submitted the proposed amendments to the Joint Committee on Administrative Rules for review. As proposed, the amendments would allow transporters of State-regulated non-hazardous special waste to use manifests that are functionally identical to the Uniform Hazardous Waste Manifest of the United States Environmental Protection Agency (USEPA)—but without the financial and regulatory burdens associated with USEPA's new e-Manifest System.

This rulemaking, which began with the Illinois Environmental Protection Agency's proposal, is captioned <u>Amendments to Manifesting Requirements</u>: <u>Special Waste Hauling 35 Ill. Adm. Board Proposes First-Notice Rule Extending 2020 Period to Renew Approvals for Cross Connection Control Device Inspectors of Public Water Supplies

Generally, a cross connection control device inspectors (CCCDIs) must renew his or her CCCDI approval each year between May 1 and June 30, as discussed earlier in this "Rulemaking Update." See 35 Ill. Adm. Code 604.1510(b)(2). Because of related licensing delays caused by the COVID-19 pandemic, the Illinois Environmental Protection Agency (IEPA) proposed and the Board adopted an emergency rule to extend this renewal period for 2020 to between August 31 and October 30. See Emergency Rulemaking for Cross Connection Control Device Inspectors of Public Water Supplies 35 Ill. Adm. Code 604.1520, docket R20-20 (Apr. 16, 2020) (adopting 35 Ill. Adm. Code 604.1520 ("COVID-19 Emergency Provisions" as emergency rule)). The emergency rule took effect on April 17, 2020.

As the Board observed when it adopted the emergency rule, the Illinois Administrative Procedure Act does not allow an emergency rule to last longer than 150 days. *See* 5 ILCS 100/5-45(c) (2018). Accordingly, the emergency rule cannot last beyond September 14, 2020, which is about seven weeks before the extended deadline of October 30, 2020, for CCCDI approval renewals. To bridge this gap, the Board opened a separate docket and, on May 21, 2020, proposed the text of the emergency rule in a general rulemaking, <u>Rulemaking for Cross Connection Control Device Inspectors of Public Water Supplies 35 Ill. Adm. Code 604.1520</u>, docket R20-21 (May 21, 2020). When it becomes effective, this rule will replace the emergency rule.

The Board accepted public comments on the proposed rule, which was published in the *Illinois Register* on June 5, 2020 (44 Ill. Reg. 9352). The Board also held two public hearings. As discussed later in this "Rulemaking Update," the Board issued its second-notice opinion and



order at a special meeting held on July 27, 2020. The Board expects to adopt a final rule at its September 3, 2020 meeting.

Board Proposes "Identical-in-Substance" Amendments to RCRA Hazardous Waste and MSWLF Rules

On May 21, 2020, for public comment, the Board proposed amendments to its hazardous waste rules. The proposed amendments are "identical in substance" to federal rule amendments made by the United States Environmental Protection Agency (USEPA) during 2019 under Subtitle C of the Resource Conservation and Recovery Act (RCRA). The USEPA actions considered were the February 22, 2019 Hazardous Waste Pharmaceuticals Rule and the December 9, 2019 Universal Waste Aerosol Cans Rule. The Board also included proposed corrections to its RCRA Subtitle C hazardous waste rules and RCRA Subtitle D municipal solid waste landfill (MSWLF) rules, many at the request of the Joint Committee on Administrative Rules and the Illinois Environmental Protection Agency.

The Board's rulemaking is captioned RCRA Subtitle C Update, USEPA Amendments (January 1, 2019 through June 30, 2019) and RCRA Subtitle D Corrections and RCRA Subtitle C Update, USEPA Amendments (July 1, 2019 through December 31, 2019), dockets R20-8 and R20-16 (consol.) (May 21, 2020). Board Proposes "Identical-in-Substance" Amendments to Ambient Air Quality Standards

On May 21, 2020, for public comment and hearing, the Board proposed rule amendments that are "identical in substance" to federal actions taken during 2019 and the second half of 2018. The federal actions were taken by the United States Environmental Protection Agency (USEPA) and concerned the National Ambient Air Quality Standards (NAAQS). The USEPA actions considered by the Board included the October 16, 2018 corrections to area designations for the 2015 NAAQS for ozone (O₃); the December 27, 2018 and May 28, 2019 area redesignations for the 1997 primary NAAQS for fine particulate matter (PM_{2.5}); the March 29, 2019, May 28, 2019, and September 26, 2019 designation of new federal reference methods (FRMs) and federal equivalent methods (FEMs) for sulfur dioxide (SO₂), O₃, and carbon monoxide; the August 23, 2019 area reclassification for O₃; the September 13, 2019 reconsideration of an area designation for the 2016 SO₂ NAAQS; and the December 15, 2019 release of an update to USEPA's *List of Designated Reference and Equivalent Methods*.

Board Proposes "Identical-in-Substance" Amendments to VOM Definition

On May 21, 2020, for public comment and hearing, the Board proposed rule amendments that keep Illinois' definition of "volatile organic material" (VOM) "identical in substance" to the federal definition of "volatile organic compound" (VOC). The proposal reflects action taken by the United States Environmental Protection Agency (USEPA) on November 28, 2018, to exclude a new hydrofluoroolefin from the VOC definition. The Board therefore proposed expanding its exclusion from ozone regulation "due to negligible photochemical reactivity." 415 ILCS 5/9.1(e) (2018). The Board also included proposed corrections to chemical names in the list of excluded compounds.

The Board held a public hearing on July 16, 2020. The Board's rulemaking is captioned <u>Definition of VOM Update, USEPA Regulations (July 1, 2018 through December 31, 2018)</u>, docket R19-15 (May 21, 2020). Board Sends PSD Permitting Rules to Second Notice

On June 18, 2020, the Board issued a second-notice opinion and order proposing a new Part 204 of its air pollution rules. As proposed, Part 204 would create Illinois' Prevention of Significant Deterioration (PSD) permitting program. To conform its other rules to the proposed new program, the Board also proposed amending its air pollution rules at Parts 230, 211, and 215, as well as its procedural rules at Parts 101 and 105. In doing so, the Board addressed each of the public comments received during the first-notice period and submitted the proposal to the Joint Committee on Administrative Rules (JCAR) for second-notice review. JCAR is scheduled to consider the proposed rules at its August 11, 2020 meeting.

On July 2, 2018, the Illinois Environmental Protection Agency (IEPA) initiated this rulemaking by submitting a proposal to the Board. Procedurally, the proposal has two main objectives: Illinois will have its own PSD program rather than IEPA implementing the federal PSD program on behalf of the United States Environmental Protection Agency (USEPA); and the Board, instead of USEPA's Environmental Appeals Board, will hear appeals of IEPA's PSD permitting determinations. In addition, IEPA stated that its proposal meets the Illinois Environmental Protection Act's requirements for establishing a State PSD program (415 ILCS 5/9.1(c); Public Act 99-463, eff. Jan. 1, 2016).

Board Adopts Amendments to Non-Hazardous Special Waste Manifest Rules

On July 16, 2020, the Board issued a final opinion and order amending its manifesting regulations on transporting non-hazardous special waste. The amendments allow transporters of State-regulated non-hazardous special waste to use manifests that are functionally identical to the Uniform Hazardous Waste Manifest of the United States Environmental Protection Agency (USEPA)—but without the financial and regulatory burdens associated with USEPA's new e-Manifest System. The Joint Committee on Administrative Rules issued a "Certification of No Objection" to the rules at its June 16, 2020 meeting. The rules took effect on July 20, 2020.

This rulemaking, which began with the Illinois Environmental Protection Agency's proposal, is captioned <u>Amendments to Manifesting Requirements</u>: <u>Special Waste Hauling 35 Ill. Adm. Board Proposes Second-Notice Rule Extending 2020 Period to Renew Approvals for Cross Connection Control Device Inspectors of Public Water Supplies

At a special meeting on July 27, 2020, the Board proposed a second-notice rule that, when it becomes effective, will replace an emergency rule extending the period for cross connection control device inspectors (CCCDIs) to renew their 2020 CCCDI approvals. This general rulemaking is discussed earlier in this "Rulemaking Update." *See* Rulemaking for Cross Connection Control Device Inspectors of Public Water Supplies 35 Ill. Adm. Code 604.1520, docket R20-21 (May 21, 2020).

The Board held two public hearings; one on June 18, 2020, and the other on July 13, 2020. JCAR is scheduled to consider the proposed rule at its August 11, 2020 meeting. The Board expects to adopt a final rule at its September 3, 2020 meeting.

Restricted Status/Critical Review

The Environmental Protection Act prohibits the Agency from issuing a construction permit that will cause or extend a violation. A construction permit to expand the distribution system cannot be granted when a water supply has a maximum contaminant level or treatment technique violation, an inadequate source of raw water supply, inadequate treatment plant capacity, finished water storage or distribution system pressure. A Restricted Status List is published quarterly in the Illinois Pollution Control Board Environmental Register to notify those persons considering expansion of a water supply distribution system of that status before large sums of money have been spent on items such as land acquisition, financing and engineering fees. A companion Critical Review List is published concurrently with the Restricted Status List and has the water supplies that are approaching a point where the supply could be placed on Restricted Status. A permit application from a supply on Critical Review will be examined carefully to ensure that the proposed construction will not cause a violation. Restricted Status and Critical Review are presented as a combined list with the status of the water supply denoted as either RS (Restricted Status) or CR (Critical Review). The current list reflects the status as of January 2, 2018. An asterisk, *, beside the water supply indicates public water supplies that have been added to the Restricted Status/Critical Review list since the previous publication.

Restricted Status List

The Restricted Status List was developed to give additional notification to officials of public water supplies which are in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act.

The Restricted Status List will include all Public Water Supplies for which the Agency has information indicating a violation of any of the following requirements: Finished water quality requirements of 35 Ill. Adm. Code, Part 604, Subparts B and C; maintenance of adequate pressure on all parts of the distribution system under all conditions of demand; meeting raw water quantity requirements of 35 Ill. Adm. Code 604.502; or maintenance of treatment facilities capable of providing water "assuredly adequate in quantity" as required by Section 18 of the Illinois Environmental Protection Act.

A public water supply on the Restricted Status List will not be issued permits for water main extensions, except for certain limited situations, or unless the supply has been granted a variance from the Illinois Pollution Control Board for the violation, or from permit issuance requirements of Section 39 of the Act.

This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.

Critical Review List

The Critical Review List was developed to give additional notification to officials of public water supplies which may be close to being in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act. A supply will be placed on the Critical Review List when Agency records indicate that it is approaching any of the violations that would place it on the Restricted Status List. This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.

Class III Special Resource Groundwater Listing Statement

In accordance with 35 III. Adm. Code 620.230(b)(2), the Illinois Environmental Protection Agency (Illinois EPA) publishes a final listing of the following dedicated nature preserves (DNPs), as Class III: Special Resource Groundwater (Class III Groundwater): Bluff Spring Fen.

Based upon the authority of 35 III. Adm. Code 620.230, Class III Groundwater can be established for groundwater contributing to a DNP that has been listed by the Illinois EPA. The Illinois EPA is required to review a written request to list DNPs, and upon confirmation of the technical adequacy, publish the proposed listing of the DNP(s) in the Environmental Register for a 45-day public comment period. Within 60 days after the close of the comment period, the Illinois EPA is required to publish a final listing in the Environmental Register, or provide the requestor with a written response specifying reasons for not publishing a final listing.

The Groundwater Section of the Bureau of Water at the Illinois EPA completed the review required, per the criteria specified in subsection 620.230(b)(1), and found the petition to be technically adequate. The proposed listing was published in Number 752 of the Illinois Environmental Register, October 24, 2019. No comments were received during the 45-day public comment period. Therefore, the Illinois EPA is publishing the following final listing of a DNP as Class III Groundwater:

Bluff Spring Fen Nature Preserve Class III Special Resource Groundwater Listing Notice A) A general description of the site and the surrounding land use.

Bluff Spring Fen is located in the City of Elgin, in northwestern Cook County. Bluff Spring Fen DNP is a 94.3 acre tract, jointly owned by the Metropolitan Water Reclamation District of Greater Chicago and the City of Elgin. The DNP is situated partly on the north and predominantly on the south side of Poplar Creek, located in portions of Sections 19 and 30, of Township 41 North, Range 9 East of the Third Principal Meridian, Cook County. The groundwater contribution area (GCA) includes parts of Sections 19, 20, 21, 28, 29 30, Township 41 North, Range 9 East, Third Principal Meridian, Cook County and part of Section 24, Township 41 North, Range 8 East, Third Principal Meridian, Kane County. The total GCA, for which Class III is proposed, which includes the nature preserve and GCA outside the nature preserve, is 2.37 square miles (1,515 acres) composed of a generally wedge-shaped area, predominantly east of the DNP, with northeasterly and southeasterly components. Land use in the proposed Class III Area is composed of approximately 0.3 percent agricultural land, 17.3 percent forest and grassland, 3.2 percent wetland, 6.7 percent open water, 60.8 percent residential/urbanized land and approximately 11.7 percent barren/disturbed land.

B) A topographic map or other map of suitable scale denoting the location of the dedicated nature preserve.

See Exhibit 1, Attachment 1.

C) A general description of the existing groundwater quality at and surrounding the dedicated nature preserve.

The presence of the high quality graminoid fen community indicates that the groundwater system retains important geochemical characteristics that support the community. Samples collected in the fen area reported pH ranging from 6.6 to 8.6 standard units, which is circumneutral, to mildly alkaline. Mildly alkaline water that is enriched in calcium and magnesium is typical of calcareous fens. Groundwater samples collected from the DNP contained concentrations of chloride from 10 to 129 milligrams per liter. Elevated concentrations chloride can damage sensitive fen plants and favor generalist species that are more tolerant of chloride and less dependent on a calcium rich water.

D) A general geologic profile of the dedicated nature preserve, based on most reasonably available information, including but not limited to geologic maps and subsurface groundwater flow directions.



The geology of Bluff Spring Fen and its groundwater contribution area can generally be described as 70 to 100 feet of unconsolidated glacial sediment overlaying Silurian age dolomite. The upper 20 feet of the glacial material is composed primarily of highly permeable sand and gravel of the Henry Formation, with some areas of peat. The Henry Formation sand and gravel is the primary conduit through which groundwater flows from the contribution area into the fen. Below the Henry Formation, there is typically 65 feet of clayey and sandy glacial till. Below the till is the dolomite, though in some areas, the dolomite may be in contact with the Henry Formation. Because of the relatively low permeability of the till, the dolomite is not believed to contribute groundwater to the fen. The fen occurs primarily on the southern slope of Poplar Creek, where the creek valley intersects the Henry Formation. Groundwater flow into the DNP occurs primarily from the northeast, east and southeast.

E) A description of the interrelationship between groundwater and the nature of the site.


Though the high quality graminoid fen is the major wetland feature, sedge meadow, mesic prairie, calcareous seep and marsh are also present. The near surface sand and gravel also support dry gravel prairie and oak/hickory savanna. All of these environments depend on the specialized hydrogeologic conditions for their continued survival. The DNP is home to eight endangered and four threatened plant species. In addition to the geochemical conditions that support the specialized wetland plants, the influx of cool groundwater creates microclimates which allow certain species, typically found further north, to survive within Bluff Spring Fen.
