The Attorney General has brought a case against the Reliable Materials, LLC, an Illinois limited liability company (Reliable), GSG Consultants, Inc., an Illinois corporation, O.C.A. Construction, Inc., an Illinois corporation, Speedy Gonzalez Landscaping, Inc., an Illinois corporation, Public Building Commission of Chicago, an Illinois municipal corporation, Board of Education of the City of Chicago, a body politic and corporate for violation of State pollution control rules. On June 17, 2014, the parties filed a stipulation and proposal for settlement as to Reliable only. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. Any person desiring that a hearing be held may demand a public hearing in this case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should refer to People of the State of Illinois v. Reliable Materials, LLC, an Illinois limited liability company, GSG Consultants, Inc., an Illinois corporation, O.C.A. Construction, Inc., an Illinois corporation, Speedy Gonzalez Landscaping, Inc., an Illinois corporation, Public Building Commission of Chicago, an Illinois municipal corporation, Board of Education of the City of Chicago, a body politic and corporate, PCB 12-52, and should be mailed to the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601.
