HEARING OFFICER ORDER

On May 25, 2016, after three days of hearing, the hearing was continued on record until June 23, 2016, at 9:00 a.m. There were numerous objections from Johns Manville (JM) regarding 'new opinions" not previously disclosed by Illinois Department of Transportation (IDOT) expert witness, Steven Gobelman.

The parties were directed to brief JM's objections and file them with the Board on or before June 9, 2016. Responses are due to be filed on or before June 14, 2016.

An issue also arose regarding the stipulated exhibits. For instance, in its Pre-Hearing Statement (Statement) filed May 17, 2016, JM stated that the "parties agreed to stipulate to the genuineness and admissibility of certain Exhibits below." Statement at 5. Counsel for IDOT questioned whether since some of the exhibits at issue have not yet been moved into evidence, but have been stipulated to, would IDOT be allowed to cite to them in their post-hearing brief. JM objected, and stated that since the exhibits at issue have not been so moved, IDOT should not be allowed to cite to them.

I directed the parties to discuss the issue further and arrive at a resolution. To date, there has been no indication that the parties have followed my directive. The parties are again directed to discuss a possible resolution to this issue. After discussion, if the issue still remains, the parties may address the stipulated exhibit issue in the respective briefs dealing with JM's objections to "new opinions" which is due to be filed with the Board on or before June 9, 2016. Responses are due to be filed on or before June 14, 2016.
