### NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory

120-day decision deadline for final action by the Illinois Pollution Control Board

("Board") in this proceeding until December 31, 2013. In support of this Notice,

Petitioner states as follows:

- 1. On October 5, 2011, Petitioner filed a Petition for Review ("Petition") of the Construction Permit issued to Petitioner by the Illinois Environmental Protection Agency ("Illinois EPA") on August 31, 2011, for an emission control system for Petitioner's basic oxygen process ("BOP") furnaces at Petitioner's integrated steel mill plant located in Granite City, Illinois.
