Dear Illinois Pollution Control Board,

I urge you to reject the request (PCB 2014-010) to let five coal plants violate Illinois air pollution limits for the next five years.

The Edwards coal plant has been operating for 52 years and does not have modern pollution controls. Pollution levels in Pekin, Illinois were documented by the EPA as the highest in the state, causing the area to be designated as in "non-attainment" by USEPA last month. (Sulfur Dioxide Standards -- Region 5 State Recommendations and EPA Responses, US EPA.)

The proposal presented in PCB 2014-010 isn't only dangerous and wrong, it is also in violation of the IPCB's own rules. The rules specify that variances can only be granted to the owners of the polluting facilities, but Ameren's sale of five Illinois coal plants to Dynegy isn't expected to be completed until the end of this year.

The request Dynegy has filed with the IPCB asks for an exemption that would allow the coal plants to exceed state pollution limits for sulfur dioxide and other dangerous pollutants for the next five years. Dynegy claims that they don't have the money to install the necessary pollution controls, which is hard to believe as in April they received over \$1.7B in loans from Wall Street. (Dynegy closes \$1.3B term loan facilities, Houston Business Journal, April 23, 2013).

Please reject the request presented in PCB 2014-010.
