

HEARING OFFICER ORDER

On December 2, 2014, the parties submitted an agreed revised discovery schedule. The revised schedule is accepted to the extent as follows: completion of all fact discovery on or before February 20, 2015; disclosure of complainant's expert(s) report(s) on or before March 16, 2015; respondent to depose complainant's expert(s) on or before March 30, 2015; disclosure of respondent's expert(s) report(s) on or before May 1, 2015; complainant to depose respondent's expert(s) on or before May 29, 2015; complainant's rebuttal expert(s) report(s) disclosed on or before June 15, 2015; expert discovery cutoff on July 2, 2015; all dispositive motions must be filed on or before August 21, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 18, 2014, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




