NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION (“Petitioner”), by and through its attorneys, HEPLERBROOM, LLC, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to a limited waiver of the statutory 120-day decision deadline in this proceeding until September 1, 2021. In support of this Notice, Petitioner states as follows:

1. On April 8, 2013, Petitioner filed a Petition for Review (“Petition”) of the Clean Air Act Permitting Program (“CAAPP”) permit (No. 96030056) (“Permit”) issued to Petitioner, on March 4, 2013, by the Illinois Environmental Protection Agency (“Illinois EPA”) for Petitioner’s integrated steel mill plant located in Granite City, Illinois.

2. The current decision deadline for this matter is June 30, 2021.

3. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until September 1, 2021.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
