HEARING OFFICER ORDER

On March 17, 2015, the parties participated in a telephone status conference with the hearing officer. The Illinois Environmental Protection Agency (Agency) continues to review inspection reports in light of respondents' updated responses, some of which were submitted last week. The People hope that the Agency's completion of review will pave the way for stipulations to be sent to all respondents. Respondents are highly dissatisfied with the progress of this case, and request that a hearing date be set, or at least a deadline for the Agency response on the inspection reports. At this time, the hearing officer is satisfied that the case is progressing, although a hearing may be set at a later date if settlement appears unlikely. The People hope to have more information from the Agency at the next status call.

The parties are directed to participate in a telephone status conference with the hearing officer at 11:00 a.m. on April 6, 2015. A conference call-in number will be circulated.
