HEARING OFFICER ORDER

On April 27, 2016 all parties participated in a telephonic status conference with the hearing officer. The respondent stated that since the last status conference, it has attempted to contact the United States Environmental Protection Agency (USEPA) for further discussions regarding the proposed NPDES permit to no avail. The petitioners and the respondent have agreed on the language but input from the USEPA is required. The respondent will continue its attempts for further discussions with the USEPA.

The petitioners stated that they will file additional waivers of the statutory decision deadline to and including September 1, 2016.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 1, 2016, at 9:30 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
