- 2) 307.3301(c)(1), 4th line: As written, you’ll end up with “;”. We think deleting the added semicolon is probably the best option. **Agree to deleting the semicolon.**
- 3) 307.3301(c)(1)(G)(ii): “must comply with more stringent limitations that already _____, instead of the less stringent limitations sought”. **After "already" add “apply”.**
