HEARING OFFICER ORDER

On February 26, 2015, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it has recently forwarded to respondent a draft permit application addressing the respondent's comments. Once accepted, the petitioner anticipates incorporating the modifications into the consent decree in the related circuit court matter. By agreement, the record in the above-captioned matter is now due on or before May 15, 2015.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 20, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 23, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.


