**UNOPPOSED MOTION FOR LEAVE TO FILE A REPLY**

NOW COMES the Petitioner, Ameren Missouri and Goose Creek Energy Center (“Ameren” or “Petitioner”), by and through its attorneys, and pursuant to Section 101.500 of the Illinois Pollution Control Board (“Board”) regulations, 35 Ill. Adm. Code Sections 101.500, requests leave to file a reply to Respondent’s Response to Petitioner’s Motion for Summary Judgment. In support, the Petitioner states as follows:


1. On March 17, 2015, Petitioner filed its Motion for Summary Judgment in this matter, and in two similar permit appeals (PCB 15-088 and PCB 15-134).
2. On April 24, 2015, Respondent filed its Response to Petitioner’s Motion for Summary Judgment.
3. Respondent has alleged facts and legal conclusions in its response that merit a response from Petitioner.
4. The undersigned has contacted counsel for the Respondent, who does not object to Petitioner filing a reply.
5. Consequently, pursuant to Illinois Admin. Code 101.500(e), Petitioner seeks to file a proposed Reply in Further Support of Petitioner’s Motion for Summary Judgment to aid this Board in evaluating the merits of Respondents’ motion.

6. Pursuant to Illinois Admin. Code 101.500(e), the Board and Hearing Officer have the discretion to allow reply briefs “to prevent material prejudice.”
7. Allowing Petitioner to file a reply will enable them to fully respond to issues of fact and law raised by Respondent in its responsive briefing.
8. For these reasons, Petitioner respectfully requests that this Board grant their Motion for Leave to File a Reply.


