
HEARING OFFICER ORDER

On September 8, 2016, all parties participated in a telephonic status conference with the hearing officer, including Albert Ettinger, an interested party. The petitioner stated that it continues to draft its responses to comments put forth by the United States Environmental Protection Agency and Mr. Ettinger regarding the variance petition. The petitioner is hopeful that the responses will be completed in the next two or three weeks. To that end, it was agreed that the respondent must file its recommendation on or before December 1, 2016.

Petitioner stated that it will file an additional waiver of the statutory decision deadline to and including March 2, 2017.
