

**HEARING OFFICER ORDER**

On October 6, 2016, the Illinois Department of Transportation (IDOT) filed a motion for extension of time to file its post-hearing brief. IDOT requests a seven day extension of time, to and including October 21, 2016. IT IS SO ORDERED.




