
HEARING OFFICER ORDER

On September 10, 2015, all parties participated in a telephonic status conference with

the hearing officer. The parties stated that they are proceeding with discovery in these cases and the related case in circuit court pursuant to a case management schedule. At present, they are conducting expert discovery. The parties stated that the circuit court matter and these cases have thus far been in lock step, but that they will eventually discuss when and how to proceed with these cases independently of the circuit court case.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 17, 2015, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


