<u>JURISDICTION</u>

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2010).

FACTS

- 1. That Nico Development Group, Inc. is the current operator ("Respondent") of a facility located at 1024, 11th Street, Rock Island, Rock Island County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Nico Tire & Grocery.
 - 2. That said facility is designated with Site Code No. 1610656096.
 - 3. That Respondent has operated said facility at all times pertinent hereto.
- 4. That on April 24, 2013 Gerald McGhee, of the Illinois Environmental Protection Agency's ("Illinois EPA") Peoria Regional Office inspected the above-described facility. A copy of the inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on <u>5-22-13</u>, Illinois EPA sent this Administrative Citation via Certified Mail No. <u>7012 0470 0001 2998 5621</u>.

VIOLATIONS

Based upon direct observations made by Gerald McGhee during the course of his April 24, 2013 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

(1) That Respondent caused or allowed water to accumulate in used or waste tires, a violation of Section 55(k)(1) of the Act, 415 ILCS 5/55(k)(1)(2010).

CIVIL PENALTY

On March 7, 2013, the Board found NICO Development Group, Inc. in violation of Section 55(k)(1) of the Act in AC 13-32.

Because this Administrative Citation addresses a second or subsequent violation of Section 55(k)(1) of the Act, pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2010), Respondent is subject to a civil penalty of Three Thousand Dollars (\$3,000.00) for each violation, for a total of Three Thousand Dollars (\$3,000.00). If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than June 28, 2013, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2010), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental

Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the Three Thousand Dollar (\$3,000.00) statutory civil penalty.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2010), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2010). If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

NARRATIVE

On April 24, 2013, I conducted a Tire Storage Inspection from 10:40 a.m. until 11:30 a.m. at Nico Tire & Grocery located at 1024 11th Street in Rock Island, Illinois. The facility is owned Nicolasa Casco and Alvaro Quintana. It is operated by Nico Development Group, Inc. The inspection was conducted as a follow up to an Administrative Citation sent to the operator on January 8, 2013. A Notice of Corrective Actions Required for Used Tire Facilities (NCARUTF) was sent to the operator on January 28, 2013. The compliance deadline required in the corrective actions notice was March 1, 2013.

I interviewed Cesar Casco. The facility sells only used tires at retail. The Used and/or Waste Tire Activity Notification Form has been submitted. The required annual fee has not been submitted. The required written notice under 55.8(a)(3) was posted. Nico Tire & Grocery is selling approximately 750 used tires per quarter. The Illinois Tire User Fee of (\$2.50) per tire is being charged properly. The Fee is being submitted to the Illinois Department of Revenue as required. Mr. Casco produced receipts dated February 17, April 5, 6, and 11, 2013 for disposal of approximately 950 used tires by Nico Tire (T7670) transported to Bell's Hauling & Recycling (T7599).

I observed about 1000 used tires stored outside under a partially covered structure. Used tires stored near the outside edge of the structure are not prevented from accumulating water. (See photographs 2, 3, 4, and 5).

I observed water in many used tires stored outside like the ones seen in photographs 3, 5, 8, 9, 26, and 33). Sampling did not reveal the presence of larval mosquitoes.

I observed about 100 used tires outside on rims and off rims on racks in front of storage structures as seen in photographs 2 and 6. Used tires stored on the racks and outside on the ground between the racks and the storage structure are not prevented from accumulating water as seen in photographs 8 and 9.

I observed about 800 used tires stored inside a storage structure. (See photographs 11 and 12).

I observed about 800 used tires stored under a storage structure attached to a building as seen in photographs 13, 14, 15, 16, 17, and 18.

I observed about 1500 used tires stored inside five transport trailers as seen in photographs 27, 28, 29, 30, and 31.

I observed about 1000 used tires stored outside underneath five transport trailers as seen in photographs 21, 22, 25, and 32.

I observed a registered transport vehicle containing about 25 used tires. It is placarded to Nico Tire (T7670). The placard is missing the letter ®. (See photographs 20 and 23).

I observed about 500 used tires stored under a three sided storage structure as seen in photographs 24. Used tires near the open end of the structure are not prevented from accumulating water as seen in photograph 26.

I also observed about 150 used tires stored between two buildings as seen in photograph 10.

The following continuing apparent violations were observed:

- 1. Pursuant to Section 21(k) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(k)), no person shall fail or refuse to pay any fee imposed under this Act.
 - A violation of Section 21(k) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(k)) is alleged for the following reason: Nicolasa Casco and Quintana Alvaro as owners and Nico Development Group, Inc. as operator failed to submit the required annual fee.
