
HEARING OFFICER ORDER

On October 29, 2015, all parties participated in a telephonic status conference with the hearing officer. It was noted that since the last status conference, R 15-21 has gone to second notice and once final, may have an impact on the above-captioned enforcement matter. The parties state that they continue to discuss the impact of R 15-21, if any, on this enforcement matter. The parties agreed that the next telephonic status conference is to be held at the date and time noted below.

To that end, it was agreed that complainant's response to respondent's affirmative defenses is now due on or before February 5, 2016. The complainant's response due date may be revisited at the next status conference.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on January 14, 2016, at 11:00 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter.

IT IS SO ORDERED.




