
HEARING OFFICER ORDER

On February 18, 2016, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that it intends to file its sixth request for a stay. It is noted that the initial stay was granted by the Board on October 17, 2013. People v. Inverse Investments LLC, PCB 11-79, slip op. at 3 (Oct. 17, 2013). The respondent stated that it was going to conduct another round of sampling at the site in the near future. The complainant expressed its objection to the additional stay.

The respondent was directed to file its written motion for an additional stay on or before March 8, 2016. The complainant was directed to file its response on or before March 25, 2016.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 7, 2016, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


