
HEARING OFFICER ORDER

On March 3, 2016 all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that the parties continue with productive settlement discussions and the exchange of information. The petitioner also stated that the plant has been recently sold and it is in the process of transferring the permit to the new owner.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 18, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 28, 2016, at 9:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




