
HEARING OFFICER ORDER

On September 23, 2014, the parties submitted an agreed discovery and dispositive motion schedule. The parties' discovery and dispositive motion schedule is accepted to the extent as follows:

Respondent to respond to complainant's outstanding discovery on or before October 23, 2014;
Completion of all fact discovery on or before February 6, 2015;
Disclosure of complainant's expert(s) reports on or before March 2, 2015;
Respondent to depose complainant's expert(s) on or before March 16, 2015;
Disclosure of respondent's expert(s) reports on or before April 17, 2015;
Complainant to depose respondent's expert(s) on or before May 15, 2015;
Complainant to disclose rebuttal expert(s) reports on or before June 1, 2015;
Expert discovery cutoff on June 19, 2015;
All dispositive motions must be filed on or before August 7, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 9, 2014, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


