EMERGENCY CLIMATE RESCUE BILL

Do propose and do enact "cap & trade", but with the added compromise as proposed by NASA Climatologist James Hansen's proposal for "fee & dividend"; as part of an EMERGENCY CLIMATE RESCUE ACT (ECRA) with the following provisions:

"Fee-and-dividend, in contrast, is a non-tax. The fee of \$115 per ton of atmospheric carbon at the mine, well-head and point of entry would appear to increase the price of fossil fuel energy. But [97%] of that fee would be distributed monthly to the public as printed Green-Energy Stamps (like the former Food-Stamps) or directly into Renewable-Energy capital accounts by electronic deposits to the bank account or debit card; or mailed Green Vouchers or a Green-Goods and Services account on State-Administered Food Stamps, to effectively cover all residents, with half shares for children, up to two children per family. With these credits good only for Green purchases and investments into Green-Businesses; & 3% for Program Admin.

"The dividend keeps families whole while providing an economic stimulus to boot. By the time the fee reaches \$115 per ton of carbon dioxide (equivalent to \$1 per gallon of gasoline) the dividend will be \$2,000-\$3,000 per legal resident per year \$6,000-\$9000 for a family with two or more children.

"People who keep their carbon footprint smaller than average will make money. The fee will rise gradually so people have a chance to choose more efficient vehicles, insulate their homes, and so on. The dividend will help people afford these investments. Jobs will be created as society retools the economy from high-carbon to low." The balance of the fee would go into US Government Green Bonds, as already enacted.

Pass a Highway Budget that funds growing, alongside Federal Highways and Interstates, camelina (a thick grass, not humanly edible, that grows well even in marginal soils, in nearly all climates, and is a good rotation crop), that can be processed into excellent bio-diesel (see testimony

of Jeff Trucksess, of Green Earth Fuels, LLC, before a Small Business Sub-Committee of the US House of Representatives [www.house.gov/smbiz/hearings/hearing-06-11-08-biofuels/hearing]), or switch-grass, a good alternative to coal, in moister climates, and to do so in public/private joint ventures including the United Mine Workers and the Oil, Chemical and Atomic Workers, Unions. And to (encourage Counties and States to do the same along their roadways.

Include a section in the law requiring gasoline-filling stations to install www.aerovironment.com ; etc.. re-charging stalls, at their

oil-company supplier's expense, by 2020 ; and battery-swapping stations from www.betterplace.com by 2025, which can be paid for by Green-Energy Victory Bonds; and by proceeds from a 50% surtax to list price per retail gallon for those oil companies that don't pay for the retrofit of their allied stations by the due date, with those tax funds to go into revolving loans at variable equal to-COLA interest rates to those companies that do the retrofitting.
